Welcome!

to a New Appraisal Year

What a relief it is to be coming out of lockdown and starting a new appraisal year this April. The pandemic has had a profound impact on us as people and doctors, and on appraisals. It has given us the new Medical Appraisal 2020 process for appraisals, with its reduction in written pre-appraisal reflection by the doctor and increased focus on how doctors look after their health and wellbeing.

Between 50-75% of doctors have missed at least one appraisal year, and all of our commissioners are keen that we support their doctors by using Appraisal 2020 this year. The process is currently being evaluated - thank you for your feedback. We expect its successor to build on what has been good about it, and to be shared in time for 2022-23.



Seed Paper Thank You

Hopefully, you will soon receive your 'Thank You' card from us. These are seed papers that you can just plant in a pot, or directly in your garden and water in, so that the flowers grow. We hope that they will bring you pleasure and remind you that all your hard work and care for your doctors is <u>much</u> appreciated.





Remote vs Face-to-Face

Until lockdown is eased, the assumption remains that all appraisals will be facilitated remotely. Once rules change, it should be the **doctor's** choice to meet either in person (with appropriate infection prevention measures in place) or online. When you tell us the date of the appraisal, we would be grateful if you could also **let us know how you have agreed to hold it**. We are monitoring this in order to let our Commissioners know the proportion of each that doctors choose.

Ease of postponing / bringing forward an appointment

This year, if you are merely moving the appraisal month a short way to find a mutually-convenient time to meet, there is no requirement to fill in a Postponement Form. In fact, we are always keen to see appraisals brought forward if it allows information to be discussed before a Revalidation recommendation is due, or to settle on a more convenient month for the appraisee. We will still need to record long-term sickness or parental leave however, and the form for that is still on our website. Find it HERE.

How to deal with missing Supporting Information

Please do not let your doctors worry this year if they are coming up for their Revalidation and missing any Supporting Information, especially the patient and colleague feedback. A Deferral Recommendation will continue their Licence to Practise to give them time to collect the information that they need, and has no negative implications for their work. Obviously, encourage those who have

the time and opportunity to do their surveys in time to reflect on them at their appraisal with you but, if this is not possible, due to COVID or any other reason, just discuss it with them during the meeting and make a plan for how they can gather the feedback they need in their new PDP. You will need to 'Disagree' the appropriate Supporting Information statement and put an explanation in the comment to the RO.

Appraisers who use PAs

A few Appraisers have been using Personal Assistants to set up their appraisal meetings, and this can lead to confusion. Please do ensure that **your own e-mail address is copied in to all communication**, so the the doctor knows who they are talking to. Please also ensure that the PA has appropriate **confidentiality clauses** in their Contract of Employment with you.
